4. The no. 96870 / 8-11-14 Interpretative Circular on Eligible Wholesale Licenses by the National Organization for Medicines.
5. The no. 133077 / 31-12-18 & 2967 / 11-1-2019 application of the company EL-PHARM SA.

6. The inspection conducted by the National Organization for Medicines on 24-25/1/2019, according to the Directive 2013C/343/01.

WE HEREBY DECIDE
